INTERNSHIP PROGRAM INFORMATION

What is the Chugach Alaska Corporation Internship Program? The Chugach Internship program provides a resource for full time students attending college to obtain their degree while gaining work experience. Work experience adds meaning to classroom instruction and allows internship participants to explore career options.

What is an Intern? An intern is a Chugach Alaska Corporation Shareholder or descendant who is enrolled and attending college full time, 12+ credits for undergraduates and 9+ credits for graduates and maintains a 2.0 or above Grade Point Average.

How many hours will I work when school is in session/not in session? Interns generally will not exceed 20 hours per week when school is in session, or 40 hours per week when school is out of session. Interns work under the supervision of a manager of Chugach Alaska Corporation or one of its subsidiaries/business partners. The intern work assignments are made within a variety of departments and disciplines.

How much will I get paid? You will be paid a competitive internship wage while you gain valuable work experience.

Will I be eligible for benefits? As an intern, you will be paid (pro-rata) for any holidays, accrue vacation and personal leave.

Will I receive performance appraisals? Yes. Quarterly Evaluations regarding your work performance will be provided, if your work or school performance falls below a satisfactory level, you may be separated from the program before you obtain your degree.

Will I be employed after completing my Internship? Not necessarily. The purpose of the program is to provide participants with valuable work experience which will in turn, provide them with marketable skills. This is a benefit for participants whether or not permanent employment with Chugach is the end result.
